

2018-2019 Visible Music College Scholarships

Visible Works Program

Visible Music College offers a number of professional development tuition-waiver opportunities each year to qualifying students. Visible Works opportunities are given to students who participate in the student work service program. The Visible Works Program tuition waiver is up to the amount of \$3,000 towards tuition.

Qualifications

- Applicant must be a full-time Visible Music College student (taking 12 or more credit hours per semester)
- Applicant must complete FAFSA (Free Application for Federal Aid) by May 1st.
- Applicant must adhere to Visible Values (including housing rules in student handbook)
- Applicant must maintain a cumulative 2.5 GPA or above
- Recipient must commit to 12 hours of campus service per week for the academic year.

Madison Line Records (MLR) Works Program

Visible Music College offers a number of MLR professional development tuition-waiver opportunities each year to qualifying students. MLR professional development tuition-waiver opportunities are given to students who participate in the MLR student work service program. The MLR Works Program tuition waiver is up to the amount of \$3,000 towards tuition.

Qualifications

- Applicant must be a full-time Visible Music College student (taking 12 or more credit hours per semester)
- Applicant must complete FAFSA (Free Application for Federal Aid) by May 1st.
- Applicant must adhere to Visible Values
- Applicant must maintain a cumulative 2.5 GPA or above
- Recipient must commit to 12 hours of MLR service per week for the academic year.

Academic Scholarship

Visible Music College offers a number of Academic Scholarships each year to qualifying students. The Academic Scholarship award is up to the amount of \$2,000 towards tuition.

Qualifications

- Applicant must be a full-time Visible Music College student (taking 12 or more

- credit hours per semester)
- Applicant must complete FAFSA (Free Application for Federal Aid) by May 1st.
- Applicant must adhere to the Visible Values
- Applicant must have a previous cumulative GPA of 3.75 or higher and maintain a GPA of 3.5 or higher GPA

Talent Scholarship (Freshman Only)

Visible Music College offers a number of Talent Scholarships each year to qualifying students (receive superior ratings at Visible Music College auditions). The Talent Scholarship award is up to the amount of \$2,000 towards tuition.

Qualifications

- Applicant must be a full-time Visible Music College student (taking 12 or more credit hours per semester)
- Applicant must complete FAFSA (Free Application for Federal Aid)& by May 1st.
- Applicant must adhere to the Visible Values
- Applicant must be nominated by a Visible Music College Faculty member (nomination comes as a result of superior marks on VMC audition)
- Applicants must maintain a cumulative 2.5 GPA or above

Visible Hope Scholarship

Visible Music College offers a scholarship to all qualifying TN resident students. This scholarship is designed to assist eligible students from the state of TN who are seeking to earn a degree at Visible Music College. The Visible Hope Scholarship is up to the amount of \$3,500 towards tuition freshman/sophomore years and \$4,500 towards tuition junior/senior years.

Qualifications

- Applicant must be a full-time Visible Music College student (taking 12 or more credit hours per semester) and remain continuously enrolled until graduation for renewal
- Applicant must complete FAFSA (Free Application for Federal Aid)& by May 1st.
- Applicant must be a TN resident for 1 year prior to May 1 application deadline
- Applicant must have a minimum ACT score of 21 or cumulative GPA of 3.0
- Applicant must meet all criteria for TN Hope Scholarship
- Applicant must adhere to Visible Values
- Applicant must maintain a cumulative 2.75 GPA or above at 24 and 48 hours and 3.0 GPA at 72, 96, and 120 hours

International Student Scholarship

Visible Music College offers a scholarship to international students. This scholarship is designed to assist students from countries outside of the USA who are seeking to earn a degree at Visible Music College. The International Scholarship award is up to the amount of \$5,000 towards tuition.

Qualifications

- Applicant must be a full- time Visible Music College student (taking 12 or more credit hours per semester)
- Applicant must be an international student not currently residing in the US
- Applicant must adhere to Visible Values
- Applicant must maintain a cumulative 2.5 GPA or above
- Applicant must complete the entire application process prior to being considered for this scholarship.

Ministry Partners Scholarship (Articulated)

Visible Music College offers a number of Ministry Partner Scholarships each year to qualifying students (students who complete ministry training programs at articulated partner institutions). The Ministry Partner Scholarship award varies per agreement with the various articulating partners.

Qualifications

- Applicant must be a full-time Visible Music College student (taking 12 or more credit hours per semester)
- Applicant must complete FAFSA (Free Application for Federal Aid) by May 1st.
- Applicant must adhere to the Visible Values
- Applicant must be have successfully completed the program at the articulating partner institution.
- Applicants must maintain a cumulative 3.0 GPA or above
- If you have completed a ministry training program that is not currently partnered with Visible Music College, you may submit your request for review and consideration for this scholarship.

Community Scholarship

Visible Music College offers a number of community scholarships each year. These are for full time students in housing in recognition in their involvement in the community.

Qualifications

- Applicant must be a full- time Visible Music College student (taking 12 or more credit hours per semester)
- Applicant must adhere to Visible Values
- Applicant must maintain a cumulative 2.5 GPA or above
- Maintain a passing grade for Worship & Accountability
- Participate in Student Life (including Winter Retreat and October-rest)
- Applicant must be living in student housing
